110.24 Welcome by the Chair

The Chairman welcomed everyone to the meeting

111.24 Apologies for absence and reasons:

112.24 Declarations of Interest: a) Pecuniary b) Personal

113.24 Public Session:

i) Albrighton Verge Improvement Project

A presentation was given by Albrighton Councillor Rachel Wild on the Albrighton Verge Improvement Project. The purpose of the project is to improve the biodiversity of plants in the verges which will impact invertebrates and for community engagement and nature connectivity. The project will be implemented in an area of land opposite Newport Rd and adjacent to the Nature Reserve. The project will not disturb daffodils already planted in the area; the aim of the project is to supplement the verges with the planting of pollinates. 'Late Managed Mow' signs will be put in place to show that the area is being managed.

ii) Speeding on Rectory Road

A member of the public had contacted the Parish Clerk and Councillors asking that a speed limit of 20mph be considered for Rectory Road. There was some discussion on this issue, with the Chairman noting that it had been looked into 3 years ago but Shropshire Council had said there was no need to reduce the speed limit as there was no crash data to justify it. Cllr Phil Ogle said that articulated lorries going down the road is a concern, there is a sign saying it is not suitable, but this is often ignored. The Chairman suggested residents contacted Shropshire Council Highways as individuals.

iii) Rectory Road Car Park

Cllr Phil Ogle noted that residents had commented on the condition of the surface of the car park on Rectory Road. The Car Park is rented by the Parish Council. Chairman said that this is something that would be taken to the new Council for consideration.
