2023.103 Welcome by the Chair

2023.107 Minutes:

It was proposed, seconded, and resolved to confirm the minutes of the Council meeting held on Tuesday 19th December 2023 as a true record

2023.108 Matters Arising

a) Asset Register

The bus shelter condition should be changed to good from fair as work has been done on it. It was requested that the Parish Clerk check the bill of sale for St Cuthbert's Meadow for inclusion. The Parish Clerk was requested to contact the Bus company and ask them to update the timetables and other information

It was agreed that the Asset Register should be considered as a fluid document, and checked twice a year. Subject to the above considerations above the current version was approved.

b) Councillor Surgeries

The Working Party has discussed how to get people to attend councillor surgeries, including combining events with other events. There is an intention to speak with the Royal British

Legion, Historical Society, and the church's men's breakfast.

Venues such as the Air Ambulance and Garden Centre have been considered but there were doubts that residents would travel there for a councillors' surgery. Overall St Cuthbert's Church remains the best venue as it is in the centre of the Parish and has parking.

Banners and advertisement could be produced for under £100, an advert in Village Life and the Parish Magazine is also an option.

Cllr David Beechey suggested that consideration could be given to a combined surgery with Albrighton Parish Council. The Chairman will discuss this with the Chairman of APC

2023.109 New Business

a) Citizen's Advice Service

Consideration was given to the request from Mrs Sylvia Pledger to contribute £1000 towards the cost of running the Citizen's Advice Service in Albrighton. There is £600 against this in the budget.

Cllr Robert Parry proposed that the Parish Council offers £800, this was seconded by Cllr Virginia Sankey.

Cllr Christine Jones proposed £1000, this was seconded by Cllr Phil Ogle.

Taking the amendment first, it was resolved to offer £1000, with 4 councillors in favour, 2 against and 1 abstention.

The budget allocation will be amended to reflect the higher amount going forward.

b) Community Governance Review

Shropshire Council's Community Governance Review of Albrighton and Donington Parishes:

Cllr Lee Chatburn had attended a discussion with the APC Chair and said that there was some ambiguity in how the review is written and that it has been interpreted differently by different councillors.

Cllr David Williams said that the two Shropshire Councillors will file a response from the Parish Councils. The Boundary Commission had redrawn the boundaries and it would affect the Nature Reserve.

a) Albrighton Village Halls Trust

A response to a letter questioning the Parish Council's alleged use of CCTV footage was considered, Cllr David Williams gave an outline of events, and said that a spokesperson had been invited to the Parish Council meeting but was not available. Cllr Lee Chatburn said that he didn't think the Parish Council should change its response.
